1. PURPOSES

- 1.1. Ensure the implementation of a quality learning process following applicable regulations and standards.
- 1.2. Provide a guideline for Lecturers and students in carrying out lectures and practices in the PPDH Program at the School of Veterinary Medicine and Biomedical Sciences, IPB University.

2. SCOPE

The scope of this procedure includes introductory lectures, the process of implementing the practice, and procedures for the student examination of the Veterinary Medicine PPDH Program at IPB University.

3. DEFINITIONS

- 3.1. Lectures are the implementation of lecture and practicum activities.
- 3.2. Practice is the implementation of activities to study, promote/improve competence and expertise on the competence standards of Indonesian veterinarians based on SKKNI. PPDH students perform the practice by applying theory obtained in S1 Strata with the guidance of lecturers, whom assistants may assist. Practice emphasizes psychomotor (skills), cognitive (knowledge through discussion), and affective (attitude) aspects. These aspects are illustrated by instructors using equipment in the laboratory (studio, microscopic observation, RSH, laboratory, and farm) according to a predetermined plan. This category also includes discussions and seminars.
- 3.3. A lecturer or educator is a person who is qualified to perform the main task of education based on educational requirements, expertise, and skills. Lecturers include coordinator lecturers, head of department lecturers, examiners, and assigned lecturers.
- 3.4. A coordinating lecturer is a lecturer who organizes all practical activities of each course during the PPDH phase in a section (stasis). A lecturer in charge is a lecturer who is responsible for supervising the implementation of PPDH practice of a group of students in a section (stasis). An examiner is a lecturer who evaluates practical

implementation results in a section. The assigned lecturer is a lecturer who is responsible for the day.

- 3.5. An assistant is a lecturer with a Veterinary degree in pharmacy and is assigned to assist faculty with practicum activities, depending on educational and expertise requirements.
- 3.6. Based on their educational requirements and expertise, educational laboratory staff is structural staff facilitating lecturers in practical activities.
- 3.7. Students are registered in the PPDH Program of the Veterinary Medicine and Biomedical Sciences at IPB University.
- 3.8. RPS: Semester Learning Plans.
- 3.9. IPK is Grade Point Average.
- 3.10. Dit. APPMB is the Directorate of Education Administration and New Student Admission.
- 3.11. PPDH: Veterinary Professional Education Program.

5. GENERAL REQUIREMENTS

- 5.1. Lecture Rules
 - 5.1.1. PPDH Program students can participate in the PPDH Program after meeting academic, administrative, and registration requirements.
 - 5.1.2. PPDH Program on campus lasts for three semesters with 37 credits.
 - 5.1.3. PPDH Program students who meet the lecture and practicum requirements have their learning progress evaluated.
 - 5.1.4. The lecture period ends after an assessment with the requirement to pass the exam with a Quality Letter of A = Very satisfying, AB = Satisfying, and B = Good. Students must achieve a final grade of at least B to pass the course. Students may retake the examination three times if they have not met the B grade. Meanwhile, if it still does not meet the requirements, students must repeat the course
 - 5.1.5. PPDH Program students who do not attend lectures and practicum activities as determined by the course regulations are not allowed to take the exam in the course.
 - 5.1.6. Students in the PPDH program who violate student life rules are subject to sanctions based on applicable regulations.
 - 5.1.7. Lecturers have the right to expel PPDH Program students who violate the ethical principles of PPDH Program lectures from the course and cancel their participation on that day. Instructors may also suspend the examination of PPDH students who cheat on the examination or behave in an undisciplined manner.
 - 5.1.8. The ethics of PPDH Program lectures and practicums include the following rules:a). Be on time for scheduled lectures.

- b). Wear neat and polite attires.
- c). Wear a laboratory coat or scrubs in the laboratory as determined by each laboratory/field coordinator. Meanwhile, wear packs and safety boots in the corral. Regulations adjust each section/activity the regulations.
- 5.1.10. In academic seminars or other formal events, PPDH Program students must wear a tie or physician's coat for men and women and neat clothing.
- 5.1.11. Always maintain attitude and manner as a Veterinarian candidate.
- 5.1.12. PPDH program students can participate in the PPDH education stages after completing academic, administrative, and registration requirements.
- 5.1.13. The PPDH implementation program consists of intramural and extramural activities. Intramural activities are educational activities conducted on the SKHB campus. Extramural activities are conducted by placing PPDH program students at private/governmental/related institutions cooperating with the Veterinary Medicine and Biomedical Sciences at IPB.
- 5.1.14. The practical teaching team may be assisted by teaching assistants and lab assistants.
- 5.1.15. Practice advisors are appointed at the beginning of each PPDH Program activity.

5.2. Requirements for the Implementation of Lecture Activities

- 5.2.1. Lecture activities in a section are conducted for four weeks (7 days/week, 24 hours/day) per parallel class.
- 5.2.2. Lecture activities are implemented according to the schedule organized by the PPDH Program and occur continuously.
- 5.2.3. PPDH Program students must actively participate in academic seminars and other scientific activities organized or recommended by SKHB.



- 5.2.4. PPDH Program students are responsible for the maintenance and safety of laboratory equipment during the activity.
- 5.2.5. PPDH Program students must compensate for damage and loss of laboratory/field equipment/equipment due to carelessness during on or off-campus activities.

5.3. Requirements for the Implementation of Substitute Lecture Activities

- 5.3.1. Suppose the student cannot attend for 1-2 days for a legitimate reason. In that case, the advisor provides a structured assignment as a substitute.
- 5.3.2. Students not participating in activities exceeding two days must take the following course semester.
